- a) Village Cleanliness: Under the Swachhta Abhiyan in Village Prini and nearby villages, the company is undertaking activities like collection and transportation of garbage from project premises and nearby villages. The company is also supporting the local community for removal of dead animal and its burial in order to prevent spread of diseases in the villages.
- b) **Women Empowerment:** The Company under the CSR plan is taking various initiatives to empower women. Around the Project site local women are trained for sewing, tailoring etc. for their capacity building.
- c) Education: The Company is paying honorarium to teachers for the local govt. schools. School bags and note books are also distributed amongst children. The company is also running a Scholarship Program at Plant location for the local community only.

Kullu, Himachal Pradesh-175143 and from this Dispensary free ECG is done for the local public as per their prescribed needs.
- **e) NGO Support:** The company is providing support to an NGO by name of Aash Child Development centre Kullu and it is run by Dr. Shruti More. This centre caters to differently abled children of Kullu region.
